VII. Comments from Lake District Residents/Good of the Lake District/Other -

Len Larsen asked how we can protect our lakes. Additional conservation methods may be needed during this time of high water to prevent soil erosion. Additional boats are able to use the public boat landing and are not following the no wake guidelines. Are we sure that these boats are being washed to prevent evasive species from being transferred from other infected lakes. The Town of St. Germain Lakes Committee will be looking at an emergency No Wake rule or a reduction of wake hours to help with the problem. Reminders of shore distance would also be good. New signs will be made to be placed at the boat landing and entrance of Engle Lake regarding electric motors only on Engle Lake.

Len Larsen asked how we can protect our fish population. Research should be done on a more restrictive bag limits, similar to a program used in Minnesota that has worked well.

Lynn Wright, restoration of Walleye in Northern WI would be a good 2021 annual meeting speaker.
