### **I. Call to order:**

Chairman Waisbrot called the meeting to order at 9:06 am.

### **II. Approval of October 24, 2015 meeting minutes:**

### **III. Treasurer's Report:**

Dave Zielinski presented the Statement of Financial Condition report for the period ending May 14, 2016. The fund balance for the period was \$23,297.96. The commission reviewed the Treasurer's report and found the Treasurer's report in order. The commission will continue to audit the budget and reports at each regular meeting.

### **IV. Committee Reports:**

#### **A. Fish Stocking and Habitat/Alma Moon Lake:**

Chairman Waisbrot briefly discussed the WDNR Fish Sticks program to update the commissioners. Chairman Waisbrot Fish reported on the stocking of Muskie in Alma and Moon Lakes for 2016. In 2014, Muskie averaging of 10 to 12 inches have been stocked in Alma (14) and Moon (32) Lakes. Crib brushing was completed two years ago and should last approximately five years.

B. Water Quality/Level:

The water level is up at this time, however there is no official measurement at this time. Water quality is being monitored, there is no report at this time. The Lakes iced over on November 24, 2015 and the ice was off the lakes on April 18, 2016. The ice was not as thick this season.

C. Web Site:

Milt Klingsporn reported the website was performing well. Milt added another plug-in for the website to monitor activity and block selected activity. Commissioner Klingsporn requested how many years of minutes should be on the website. The commission recommended two years of minutes be accessed on the site.
